7. Eligibility

- 1. The admission to the Doctoral degree programme shall be in all the subjects in concerned department where Post Graduation programmes are being offered by the Institute.
- 2. For Allied or trans disciplinary research, the admission shall be made on the availability of subject guide.
- 3. The applicants for admission to the Ph.D. programme shall possess any of the following qualifications, namely:
 - a. Post Graduate degree in Ayurveda from a recognized University or Institute established by law; or
 - b. Post Graduate degree in Ayurveda Pharmacy [M. Pharm (Ayurveda)] or Medicinal Plants (M.Sc. (Medicinal Plants)] or concerned field as per specialty from a recognized University or Institute established by law; or
 - Postgraduate degree in Allied or Transdisciplinary subject from any recognized University or Institute established by law.
- 4. The eligibility qualifications for Foreign Nationals are the same as specified in these regulations for Indian Nationals and further, they are required to submit their applications through Indian Council for Cultural Relations.
- 5. Master's degree in the appropriate discipline of any recognized University/Institute or equivalent, with a minimum of 55% marks in aggregate (of all the years/ semesters) where marks are awarded or minimum

equivalent Cumulative Grade Point Average (CGPA) as defined by regulatory bodies/University or any other competent body as the case may be.

- 6. Those candidates who are not having or mentioned any marks in their PG degree by recognized University they are also eligible for admission in Ph.D.
- 7. A relaxation of 5% or equivalent grade point in the minimum eligibility shall be applicable to the applicant belonging to the categories of SC/ST/OBC (Non Creamy Layer) and Differently abled persons or categories decided by UGC or those who had obtained their Master's Degree prior to 19th September,1991. The eligibility marks of 55% (or an equivalent grade in a point scale wherever grading system is followed) and the relaxation of 5% to the categories mentioned above are permissible based only on the qualifying marks without including the grace marks procedure.
- 8. A candidate may apply for registration for the degree of Doctor of Philosophy (Ph.D.) in the Faculty of Ayurveda provided that he/she has Ayurveda Vachaspati/ Dhanwantari [M.D./M.S.(Ayurveda)] degree of the University or as equivalent degree recognized by the University for the purpose.
- 9. All applicants have to apply for the entrance test in specified format along with fees decided by the authority from time to time.
- 10. The applicants appearing in the final year examination of their respective Post Graduate degrees may also apply for entrance test; however, their registration shall be subject to their passing in those examinations at the time of registration.
- 11. The Central Government-sponsored international scholars shall be exempted from entrance test: Provided that they have to complete the course work decided by the Institute.
- 12. Any faculty member of the University Constituent Colleges shall be considered equivalent to a full-time PhD candidate, depending on availability of seats and therefore eligible for admission provided they clear the PhD entrance exam and fulfill point number (4) mentioned in entrance examination.
- 13. If failure in fulfilling the seats of a subject, any scholar as per rules of allied subjects is eligible for admission under that subject's guide.
- 14. A foreign student of any faculty shall be required to present himself/herself for such registration. His/her case will be considered only if he/she has come on research visa and having a post graduate degree recognized by NCISM. In case of large number of foreign student's applications for Ph.D. an entrance test may be conducted depending upon the availability of the seats.
- 15. Applications of In-service candidates must be duly forwarded by the employer to the university in prescribed format thereof by the last date of submission of application form.
- 16. The Ph.D. shall not be recognized in case if
 - a. The Ph.D. Scholar & Ph.D. Supervisor are at different place during the research period.
 - b. The working place of Ph.D. Scholar and the research place registered for Ph.D. are different.

8. Fellowship

Candidates having sponsorship/assistantship/fellowship/any financial support from state or national level agency, etc. shall be given preference in admission in the full-time regular Ph.D Programme, however, candidates without any financial support as above, shall be eligible to take admission to full time Ph.D programme.

9. How to Apply (Admission Process)

9.1 Submission of Application & Fees

- 1. Online Application form is available at university website: https://phdadmission.rauonline.in
- Candidate is required to Apply online prescribed format and with online deposit of application fee Rs. 1000/(Rs. One thousand only).

9.2 Entrance Test (Scheme of Exam)

- The eligibility test shall be based on knowledge of Ayurveda with special focus on the concerned subject of
 specialty current advances in Medical Science, Research Methodology, Biostatistics and there shall be one
 question papers containing two different parts of multiple-choice questions format, namely, Part I and Part II
 bearing equal weightage of fifty marks each.
- 2. Part Ist shall comprise the questions on Research Methodology and Biostatistics along with the current advances in Health Sciences and it shall be common for all the applicants and Part II shall be subject specific.
- 3. The duration of the entrance test shall be ninety minutes.
- 4. An applicant has to secure a minimum of fifty percent cumulative marks for qualifying the examination for the General or the Other Backward Classes or the Social and Economically Backward Classes categories and forty-five percent for the Scheduled Cast or Scheduled Tribes categories. These candidates will be considered qualified for being called for interview taken by a duly constituted committee. Final result shall be declared after interview.
- 5. If applicants of the same category and of the same specialty, score cumulative equal marks in entrance test, the marks obtained in Part I shall be considered for the merit and in the condition of scoring equal marks in Part I, the marks secured in the final year graduation theory exam shall be considered for merit place. In case where the total final year BAMS marks are also found equal. Total marks of the 12th standard will be considered to decide merit.
- 6. The selection of the Allied or Trans disciplinary scholars shall be based upon the University Grants Commission guidelines.
- 7. Simply qualifying the PhD entrance test does not give right to candidate for getting admission, it is subjected to availability of seats, facilities and fulfilling other criteria.

- 8. The seats and guides will be allotted to the candidates strictly on the basis of their merit in interview/entrance test for the Ph.D. seats.
- 9. Applicants applied under interdisciplinary/ trans-disciplinary category will be devoid of entrance examination.

9.3 Syllabus for Entrance Test

Syllabus for entrance test will be level of Post Graduate Course.

9.4 Declaration of Result of Entrance Test

- 1. Result of entrance test shall be valid for current year only and it cannot be used for admission during subsequent year. Final result shall be declared after interview.
- All the information relating written examination, result, interview, course work etc. shall be uploaded on university website. Candidates should frequently visit the website for updated information. Therefore, applicants are advised to check website regularly.

10. Joining and Registration

- 1. Candidates will join the concerned department after submission of required documents and admission fees. The departmental heads should verify the facts in this regard before allowing the candidates to join.
- 2. In-service candidates may join after submitting their No Objection Certificate issued by their parental department.
- 3. A copy of joining letter of the candidate, counter signed by HOD will be given to university through the Principal/Director.
- 4. The date of joining along with submission of admission fees by the Ph.D. scholars shall be counted as beginning of Ph.D. term.
- 5. The Head of the institute/ college will forward the Synopsis to the University office for registration, after getting approved from the Departmental Research Committee (DRC), Institutional Research Committee (IRC) and Institutional Ethics Committee (IEC). The Head of the institute/ college will verify for the following:
 - a. Whether the candidate is eligible for registration.
 - b. Whether the candidate is within the permission quota of the supervisor.
- 6. The application for registration shall be placed before the Hon'ble Vice-Chancellor, who after satisfying himself in regarding to verification of eligibility of Supervisor, required fees, requisite qualifications, title concerned to the topic etc.; will issue permission for the registration.

11. Allotment of Stipendiary and Non-stipendiary seats. -

1. In case of stipendiary seats, the available seats shall be allotted equally among all the departments and in case when sufficient scholars are not available in concerned departments, the remaining seats shall be allotted to

2. In case of non-stipendiary seats, the qualified candidates may opt for seat as per subject availability and availability of seats under guide.

12. Submission & Approval of Research Proposal

12.1 Course Work.-

- 1. All research scholars shall compulsorily complete Research Methodology and Scientific writing course work of six months duration organized by the Institute.
- 2. The syllabus of course work shall be decided by the concerned department and approved by the Academic Council from time to time;
- 3. The research scholar has to secure fifty-five percent marks to qualify.
- 4. Duration of course work shall be maximum up to 6 months. This duration shall be counted in completion of research work. In case a candidate fails in course work examination fully/partially, he shall be allowed to reappear in the next course work examination conducted by the University on deposition of prescribed fee/registration fee as per University Rules. However, attendance shall not be compulsory for reappearing in the course work examination. The course work examination shall normally be conducted twice a year.
- 5. If a candidate fails to clear course work examination in two attempts, his/her admission shall be treated as cancelled.

12.2 Synopsis.-

- 1. After satisfactorily completion of course work, the research scholar shall submit their synopsis of research project under the guide or supervisor to the Departmental Research Committee for approval.
- The Departmental Research Committee shall forward the approved synopsis through the Head of the Department to the Dean (Research) of the Institute for proposal defense before Institutional Research Committee and the Institutional Research Committee may approve the proposal with in period of fifteen days.
- 3. At the time of proposal defense, the research scholar shall invite all the teachers of the institution to appraise the synopsis and to receive suggestions for improvement of the proposed research work.
- 4. The Dean (Research) shall forward these synopses to the Institutional Ethics Committee or Institutional Animal Ethics Committee for approval, as applicable.
- 5. The Dean (Research) shall forward the approved synopsis, to the Controller of Examination for registration of the title with in a period of fifteen days.
- 6. Any alteration in the Ph.D synopsis including title of the Ph.D. research project shall be approved by the Institutional Research Committee and Institutional Ethics Committee or Institutional Animal Ethics Committee on the basis of the recommendation of concerned Departmental Research Committee within six months of the registration of the scholar.

13. Enrollment

Every candidate shall be duly enrolled as a Bonafide research student of the University on payment of the prescribed fee. 14. Fee Structure

15. Duration of Research Work

- 1. The tenure for the Doctoral degree programme shall be three years from the date of joining.
- 2. In case of research work is not completed within stipulated period, on the recommendation of the concerned supervisor or guide, the Departmental Research Committee may grant extension up to two years.
- 3. In case of incompletion of the research work within the time period of five years maximum extension of one year may be granted by the Director on the recommendation of the Departmental Research Committee.
- 4. In case the total time required or taken exceeds six years from the date of initial registration, the research scholar shall have to re-register for Ph.D for further period of two years.
- 5. The female research scholar and person with disability (having more than forty percent disability) may be allowed an additional two years, however, the total period for completion of a Ph.D. programme in such cases should not exceed ten years from the date of admission in the Ph.D. programme.
- 6. For stipendiary seats, term of Ph.D. stipend shall be of thirty-six months from the date of joining the Ph.D. programme.
- There shall be two Ph.D. terms in a year, which shall start from January of each year i.e. January to June and July to December.

16.Registration

- 1. Every research scholar shall pay the fees as notified by the Institute from time to time.
- 2. Each research scholar shall have a valid registration at the time of submission of thesis.
- 3. The registration of a scholar shall be cancelled, after due approval of the Institutional Research Committee, in any one of the following eventualities namely: -
 - (a) if the research scholar remains absent for a continuous period of one month without prior intimation and sanction of leave;
 - (b) if the research scholar withdraws from the Ph.D. Programme and the withdrawal is duly accepted by the Institutional Research Committee;
 - (c) if the research scholar fails to pay the fees in any academic year subject to the provisions contained in these regulations;
 - (d) if progress of research work is found unsatisfactory in three consecutive terms; and
 - (e) if research scholar is found involved in an act of misconduct or in discipline or both.

17. Approval of registration-

- 1. The application for registration shall be placed before the Vice-Chancellor, who after satisfying himself in regarding to verification of eligibility of Supervisor, required fees, requisite qualifications, title concerned to the topic etc.; will permit for the registration.
- 2. Website upload -University shall maintain the list of all PhD registered students on its website on year wise and department wise basis.
- 3. Process of joining and approval of Research Proposal.
 - I. Candidates will join the concern dept. after submission of admission fees. The departmental heads should verify the facts in this regard before allowing the candidates to join.
 - II. A copy of joining letter from the candidate counter signed by HOD will be given to university through the Principal/Director.
 - III. The date of joining along with submission of admission fees by the Ph.D. scholars shall be counted as beginning of Ph.D. term.

- IV. After completion of admission process each research scholar shall submit his research proposal as approved by the allotted supervisor(s) to Head of the Department concerned for consideration of the DRC.
- V. The DRC shall consist of the DRC members, supervisor(s) and one subject expert (to be appointed by the DRC Chairperson from a panel of names suggested by the supervisor).
- VI. The committee shall examine the research proposal and suggest suitable modification/ alterations if any. The student shall incorporate suggested changes and resubmit the research proposal to the satisfaction of the committee.
- VII. The committee shall submit the research proposal to the Research Board for approval.
- VIII. If at any stage, the student wishes to modify the research plan and/or change the title of the thesis approved earlier, supervisor shall arrange the proposal to be put before the committee and the student shall make a presentation before it with the details of the proposed modifications and its justifications. The committee shall make appropriate recommendations for approval of the Research Board.

18. Stipend or Fellowship

- 1. The Institute shall award Stipend or fellowship to the eligible research scholars in accordance with the norms as laid down by the university.
- 2. The research scholars shall require to be involved in teaching assistance as assigned by the respective Guide or Supervisor or Head of the Department.
- 3. All research scholars who have been awarded stipend or fellowship by the Institute shall devote their entire time to Doctoral research and shall not engage him or herself in full-time or part- time professional practice or employment with public or private institutions or organisations and for the purpose an under taking about the same shall be submitted by the scholar at the time of admission.
- 4. The admission to the Ph.D. programme and award of stipend or fellowship shall not be linked and admission to the programme shall not guarantee fellowship and those who are not awarded fellowships can continue with the programme as self-financing scholar.
- 5. The stipend or fellowship, if awarded, shall be available only for maximum of thirty-six months as per rules.
- 6. No stipend or fellowship shall be given for the leave period except for paid leave

19. General Information

19.1 Leave

- The scholars shall be allowed casual leave up to ten-day se ach year and this leave can be joined with the
 holidays or Sundays and the research scholars can avail such leave maximum up to six days at a time
 including holidays and in between holidays shall be considered as holidays and the casual leave shall not be
 joined with medical leave and this leave can't be carry forwarded.
- 2. The research scholars shall be allowed fifteen days medical leave in a year on submission of medical certificate of a registered medical practitioner and this leave shall not be carry forwarded.
- 3. Wherever eligible, maternity or child care leave shall be given to the research scholars as per the Maternity Benefit Act, 1961(53 of 1961) however, after joining, such scholars have to complete the study period as

mentioned at sub-regulation (1) of regulation 13 and further, such leave shall be allowed once during the period of study on production of substantial document and, no any kind of leave shall be attached with this leave.

- 4. The Director has power to sanction up to thirty days leave in extra ordinary circumstances and no stipend shall be paid for such kind of leave which is sanctioned in extra ordinary circumstances.
- 5. The duty or special leave shall be granted to the research scholars who are deputed or allowed by the authority to take part in the sports, seminar and such leave shall not exceed fifteen days in a year.
- 6. The leave may be extended maximum up to further fifteen-day in special case by the Director.
- 7. The research scholar shall be allowed to avail medical leave under any special circumstances up to maximum sixty days without stipend under medical ground with the valid medical certificate issued by the registered practitioner.
- 8. The period shall not be counted to fulfill the minimum specified tenure for Doctorate degree.
- 9. Any unreasonable leave or absence availed by stipendiary or non-stipendiary scholars without the previous approval of the competent authority or in excess of limit mentioned above as per sub-regulation (1) to (5) shall be treated as willful absence and no stipend shall be granted for such period and it may also invite disciplinary action which includes termination of the candidature and recovery of the stipend paid by the Institute.
- 10. The research scholar may be allowed to carry out his research work in the approved research cons approved by the competent authority, as per the approved research synopsis, with prior approval from the Departmental Research Committee and his leave period shall be considered as on duty, on submission of certificate from the concerned centers and the total duration of such period still not exceed <u>testall minesty</u> days during the entire Ph. D. tenure.
- 11. By considering specific research work the Chairperson, Institutional Research Committee or Director may approve more days on recommendation of the Departmental Research Committee and no allowances in term of travel, food and accommodation shall be paid during the on-duty period.
- 12. The above leave regulations shall also apply to research scholars admitted on non-stipendiary seats.
- 13. The leave shall not be claimed a so fright and the authority reserves the right to cancel the leave without any explanation.
- 14. Teacher candidates will be governed by State Govt. or Centre Govt. rules applicable to that institute or college.

19.2 Criteria for break and re-joining the course

If the scholar gets selected for a permanent appointment in any government body during the tenure of Ph.D. course. He/ She may be allowed to join the services after completion of minimum one year tenure by the university on recommendation of Director/Principal. He/she may be allowed to rejoin the course after reliving from the office where he/she had joined services. If the scholar fails to resume his/her study within three years of relieving, scholar's

registration will automatically be cancelled and have to refund the amount of fellowship received and the amount of bond. Before re-joining the Ph.D. course, he/she must get the NOC from the institution. This should be done with the permission of the University.

19.3 'Doctoral Degree' shall mean the Degree awarded by the Dr. Sarvepalli Radhakrishnan Rajasthan Ayurved University, jodhpur in accordance with the provision of these regulations in the following disciplines namely


